These are integral parts of the course, they are absolutely mandatory, and you need to attend them to succeed in the course.

## **Course Description/Learning Objectives:**

Since this is an introduction to philosophy, the central questions we will reflect upon in this course are: What is philosophy? What is it about and what are its goals? How does it proceed? What is a philosopher? A number of different answers to these questions will be presented, but we will examine chiefly those of the Ancient Greek Philosophers, studying some of what they said about the nature and methods of philosophy, and some of what they left us in terms of philosophical conclusions.

The format of the lectures will be oral, and will not involve Power Point or slides of any type. Recorded lectures will consist in a spoken presentation of the material by the professor on the issues to be considered. You will be notified in advance of the topics and readings to be discussed. Some videos might also be included. No transcripts of the recordings will be provided. You should listen to them, reflect, try to understand, and relate their content to the readings. Note that all of these steps, even if they are time-consuming and require an effort, are necessary for you to integrate the material and are normal in the context of a philosophy course. They have nothing to do with the covid 19 situation and its online environment, i.e., they would be required even if the totality of the

course were delivered in a physical classroom. In person sessions will be devoted to shorter presentations by the professor. They are also meant for students to ask questions, get clarifications, interact and engage in discussion, if they wish to do so. In-class tests will also be held then.

Here is the order in which topics will be covered. The determination of a period of time devoted to each is tentative only, for it varies a lot depending on particular groups.

### Weeks 1-6: Part I General Considerations

Definition of philosophy, its division, its methods (natural mode of knowledge; logic; particular methods), historical survey

Selection of readings from Pieper's Leisure the Basis of Culture and The Philosophical Act; Aristotle's Metaphysics, Parts of Animals; Thomas Aquinas' Commentaries on the Metaphysics, the Posterior Analytics and the Nicomachean Ethics

Weeks 7-12: Part II Examination of a problem in Ethics: The Nature of Human Happiness

Selection of readings from Plato's *Apology of Socrates*; Aristotle's *Nicomachean Ethics*; Aquinas' Commentary on the *Nicomachean Ethics* 

# **Required Texts and Readings:**

You will be provided on UW LEARN with documents entitled 'Guidelines for Study', which are lists of the main questions raised in the lectures and of the readings to be done. These are to help you to take and to structure your course notes and to keep up with the readings. You will also be provided with a number of handouts. You must obtain at the UW bookstore: *Leisure*, *The Basis of Culture*, by Josef Pieper. The rest of the readings are available to you through the electronic reserve of the UW library. If you prefer, you can get these same readings in a courseware format at the UW bookstore.

### **Course Requirements and Marking Scheme:**

There will be five in-class examinations (September 29; October 6; October 27; November 17; December 1). These tests will each be worth 8%, 8%, 24%, 35% and 25% of your final grade. They will consist of multiple-choice, true or false, short answer questions and essay questions. They will be cumulative and will cover the lecture material and the reading material. We will go over the correct answers in class.

# **Attendance Policy, Late and Missed Tests:**

I emphasize that class attendance is critical for good performance in this course. As for missed tests, I am forewarning you that I will be following strictly the UW policy. That means that if you are prevented from writing a test because of sickness not related to flu-

like symptoms or COVID-related illnesses, a medical certificate must be presented and must provide all of the information requested by the "University of Waterloo Verification of Illness" form or it will not be accepted. It is better for all parties involved that you take good note of this at the beginning of the term. In case of cancellation of in-person classes, whether for this particular course or University-wide:

If it is a short-term (e.g., one-week) cancellation, we will simply keep up with the regular schedule. If it is a longer-term cancellation, in-person meetings will be held synchronously online through Webex (UW Learn) at the regular time. If midterms or final examinations have to be cancelled, questions will be posted on UW Learn. You will be asked to type all of your answers in a Word document (no PDF, no Pages), with your name as the title on the icon and submit it through UW Learn drop boxes. I also need your name and your student id at the top of the first page of your document. If you cannot attend in-person classes due to self-isolation, you should contact students in the class, in order to borrow course notes to catch up. If you cannot attend make-up test sessions due to self-isolation, a special test will be provided to you to do as a take-home.
